






HOTEL OVERVIEW






CONTRACTED GROUP BLOCK



TERMS & CONDITIONS

EVENT SPACE RENTAL

Event pricing is based on a 4 hour space rental, pricing is subject to change based on seasonality and peak times. The space is provided as is, furniture movement, removal and replacement are subject to additional fees. Pricing for additional rental hours can be provided upon request.

CANCELLATION

On a case by case basis we only offer date changes which are based on availability and may incur a rebooking fee. We do not offer refunds for event cancellations.

PAYMENT

A signed agreement with completed credit card authorization form are required to secure the event booking. A 50% deposit is billed at time of contracting, the remaining balance is billed 14 days prior to the event date and any overages will be trued up at the end of the Event.

PARKING

Although the hotel has a parking lot, it is not large enough to accommodate non-hotel guests, and street parking can be limited. We encourage clients to procure a Lyft or Uber code for their guests to eliminate parking needs.

TERMS & CONDITIONS

PRICING

A food and beverage minimum and rental fee are required for all private events. If the client fails to spend the contracted food and beverage minimum, the difference will be charged as a food and beverage assessment.

TAXES & FEES

Unless specified otherwise, all event pricing is subject to 7% states sales tax, 5% administrative fee. Food and beverages are subject to 20% gratuity. Taxes and fees are subject to change without notice.

GUARANTEES

Final menu selections are required a minimum of 30 days prior to the event date and the final guest count is required 14 days prior to the event date. Menu selections submitted after the 30 day cutoff may be subject to a \$250 rush fee, menu items are subject to availability.
